1. OVERVIEW OF THE BULK FSI UPLOAD FACILITY

The Bulk FSI Upload facility described in this User Guide allows a Member to upload into RITS a file containing multiple LVSS File Settlement Instructions (FSIs). This functionality is aimed at facilitating efficient submission of FSIs to RITS in the event of a contingency where a Member is not able to send FSIs to RITS via COIN or SWIFT FileAct, the normal channels used by Members for submitting FSIs to RITS.

The file containing FSIs will be uploaded into RITS via the RITS User Interface (UI). The uploading user will select the file from their PC using a standard Windows Browser. Upon submission, RITS will perform security and format checks. Where one or more FSIs fail these checks the entire file will be rejected. All FSIs in the file must pass security and format validation for the file to be uploaded successfully. Following a successful upload RITS will separate the contents of the file into individual FSIs. In doing so, RITS will perform business validations on each FSI. FSIs failing business validations will be rejected. RITS will accept those FSIs that pass business validations.

This User Guide should be read in conjunction with the 'Bulk FSI Upload Facility Member Technical Specifications document'¹ and XML schema², available on the RITS Information Facility. It provides information on the file formats to be used in uploading a file as well as other aspects of the functionality such as file naming standard, processing of FSIs sourced from an uploaded file and generation of associated LVSS Advices and Responses.

The uploading of Bulk FSI Files via the RITS UI can occur in all RITS sessions, including the Overnight Enquiry Session. However, settlement will only occur in normal RITS settlement sessions. As with automated FSIs, and unlike RITS Cash Transfers, FSI input requires only data entry by one member; it is not matched by a counterparty entry.

1.1 Available Functions for Bulk FSI

Bulk FSI Enquiry - Enquire on the status and details of a Bulk FSI File.

Bulk FSI Upload – Enter a Bulk FSI File to be uploaded.

Bulk FSI Delete – Delete a Bulk FSI File that is awaiting authorisation.

Bulk FSI Authorise – Authorise a Bulk FSI File if authorisation is set on the function.

1.2 Roles Relating to the Available Functions

RITS Members can use two roles to control access to the Bulk FSI Upload functionality: **Bulk FSI Upload** and **Bulk FSI Authorisation**. These roles need to be assigned to users to gain access to those functions. In addition, the Member Enquiries and Overnight Enquiry roles have access to the **Bulk FSI Enquiry** function.

1.3 RITS Menu

After logging on to RITS, the Main menu is displayed on the left-hand side of the screen. Select the **Bulk FSI** expandable tab to expand the menu as displayed below. The available options are **Bulk Enquiry, Bulk Upload, Bulk Delete** and **Bulk Authorise**.



The **Bulk Enquiry** menu tab provides access to the **Bulk FSI Enquiry** function, in which the user can check the status and details of a Bulk FSI File that has been submitted to RITS.

The **Bulk Upload** menu tab provides access to the **Bulk FSI Upload** function that enables the user to upload a Bulk FSI File into RITS.

The **Bulk Delete** menu tab provides access to the **Bulk FSI Delete** function, in which the user can delete an existing Bulk FSI File which is pending authorisation.

The **Bulk Authorise** menu tab provides access to the **Bulk FSI Authorisation** function, which is used to authorise a Bulk FSI File that has been submitted using the RITS User Interface (if authorisation is set on the function).

1.4 Bulk FSI File Status Definitions

Status	Description
Awaiting Authorisation	The Bulk FSI File has been submitted using the RITS User Interface and is awaiting authorisation.
Processing	The Bulk FSI File has been submitted using the RITS User Interface and is being processed.
Deleted	The Bulk FSI File has been deleted prior to being authorised.
Uploaded	The Bulk FSI File has been uploaded after being successfully validated.
Error	The Bulk FSI File cannot be processed further and was not uploaded.

2. BULK ENQUIRY

The purpose of this function is to allow the user to enquire on the status and details of Bulk FSI Files.

2.1 Key Points

- This function can be accessed by users who have been allocated one or more of the following roles: the Bulk FSI Upload or Bulk FSI Authorisation or Member Enquiry or Overnight Enquiry.
- This function has three elements enquiry filter, enquiry list and enquiry details.
- Only Bulk FSI Files successfully uploaded into RITS are listed in this enquiry (including those authorised or deleted). Unsuccessful attempts to submit a Bulk FSI File for upload are not listed in this enquiry.
- Enquiry filters (File Format, Upload Date and Status) are provided to assist the user refine the list.
- A Bulk FSI File can be selected to view its full details, and information on individual FSIs contained within it.

2.2 Enquiring on a Bulk FSI File

Select **Bulk Enquiry** from **Bulk FSI** tab on the menu. The following screen is displayed.

2.2.1 Bulk FSI Enquiry - Filter

If a filtered search is required, enter the appropriate filters and select **Find**.

2.2.2 Filter Criteria for Bulk FSI Enquiry

Field	Description
File Format	Select a file format from the drop down list box or leave as All.
Upload Date	Select an archive date (past 7 days) from the drop down list box. Defaults to <i>today's date</i> .
Status	Select the status from the drop down list containing Uploaded, Await Auth, Deleted, Error and Processing, or leave as All.

2.2.3 Actions

Button	Description
Find	Select to populate the Bulk FSI Enquiry - List screen with results based on the filter criteria. If no results are found, the message "No records found for this query" is displayed.
Clear	Select to clear any list contents and reset the filter fields to their default values.
Printer Icon	Select to print the page.

2.3 Viewing individual Bulk FSI File details

Selecting a row in the **Bulk FSI Enquiry** - **List** will display more details about the selected Bulk FSI File. Other Bulk FSI Files on the list can then be viewed by scrolling using **<Prev** or **Next>** buttons on the details page.

2.3.1 Bulk FSI File Details

The Bulk FSI Enquiry - Details screen shows the key details of the selected Bulk FSI File. The **File History Details** panel of the **Bulk FSI Enquiry - Details** screen (shown below) shows the date and time at which a user performed an action on the Bulk FSI File. A File Summary panel at the bottom of the page displays selected details of each of the individual FSIs contained in the file.

3. BULK UPLOAD

The purpose of this function is to allow users to upload a Bulk FSI File into RITS.

3.1 Key Points

- This function can be accessed by users who have been assigned the Bulk FSI Upload role.
- Only one Bulk FSI File can be uploaded in a single submit.
- The Bulk FSI File to be uploaded is selected in a standard Windows file browser.
- The user will be required to verify the file format of the Bulk FSI File being uploaded.
- The user will be required to verify the Bulk FSI File details on screen before confirming the upload.
- If authorisation is set, the Bulk FSI File will need to be authorised by a different user.
- Following successful submission, the status of the Bulk FSI File can be viewed through the Bulk FSI Enquiry function.

3.2 Preparing a Bulk FSI File

Instructions on how to prepare a Bulk FSI File can be found in Section 3 of the Bulk FSI Upload Facility Member Technical Specifications document, available on the RITS Information Facility.¹If users need to edit CSV-formatted bulk FSI files prior to uploading, it is recommended that this is done using a text editor program such as Notepad, rather than Microsoft Excel. Conversion from Microsoft Excel into CSV format may result in formatting errors leading to a rejection of the file in RITS.

If users need to edit XML-formatted bulk FSI files prior to uploading, it is recommended that this is done using an appropriate text editor program such as a HTML editor or Notepad.

3.3 Uploading a Bulk FSI File

Select Bulk Upload from the Bulk FSI tab on the menu. The following screen is displayed.

3.4 Bulk FSI Upload – Choose File to Upload

When a user selects **Browse** in the **Bulk FSI Upload** screen, this will bring up a **Windows file browser**. The user will be required to navigate to the required directory or folder and select the Bulk FSI File that they wish to upload. Once a file is selected and the user selects **Open**, the user is returned to the **Bulk FSI Upload** screen with the **Bulk FSI File** field populated with the location and name of the selected Bulk FSI File.

3.5 Bulk FSI Upload Confirmation

The **Bulk FSI Upload Confirmation** screen allows the submitter to verify selected details of the Bulk FSI File to be uploaded before confirming the upload.

The fields on **Bulk FSI Upload Confirmation** are display only and cannot be edited. To select a different file to upload, select **Cancel** to return to the **Bulk FSI Upload** screen and select **Browse** to choose a different file.

3.6 Bulk FSI Upload Notification

The Bulk FSI Upload Notification screen is shown when **OK** is selected in the **Bulk FSI Upload Confirmation** screen.

If a member has Bulk FSI Authorisation turned ON, upon completion of Bulk FSI Upload, the Bulk FSI File details are recorded and await authorisation. If a member does not have the Bulk FSI Authorisation turned ON, upon completion of the Bulk FSI Upload, the Bulk FSI File is immediately processed.

3.6.1 Bulk FSI Upload Notification Screens

As authorisation can be turned on or off in this function, the **Bulk FSI Upload Notification** screens will be different for each case, depending on whether authorisation is used. The screens shown below illustrate both cases.

3.6.2 Actions

Button	Description
Close	Select to close the notification screen and return to the Bulk FSI Upload screen populated with the default values.

4. BULK DELETE

The purpose of this function is to allow users to delete a Bulk FSI File that is awaiting authorisation. This may be required if the incorrect file has been uploaded.

4.1 Key Points

- This function provides the ability to delete a Bulk FSI File.
- Only Bulk FSI Files awaiting authorisation can be deleted. If the Bulk FSI File has already been processed, the Manual FRI functionality may be used to remove the individual FSIs.
- This function can be accessed by users who have been assigned the Bulk FSI Upload Role.
- This function has three elements delete filter, delete list and a delete screen.
- The contents of the Bulk FSI File cannot be amended.
- Any user with the Bulk FSI Upload role can delete a Bulk FSI File even if they were not the entering user.

4.2 Selecting a Bulk FSI File for Deletion

4.2.1 Bulk FSI Delete - Filter

Select **Bulk Delete** from the **Bulk FSI** tab on the menu. The following screen is displayed.

5. BULK AUTHORISE

The purpose of this function is to enable users to authorise a Bulk FSI File, if authorisation is required.

5.1 Key Points

- Only Bulk FSI Files with the status of 'Await Auth' may be authorised. A user must have the Bulk FSI Authorisation role to be able to authorise Bulk FSI Files.
- This function consists of a list screen and details screen.
- This function allows a user to enquire on and authorise single or multiple Bulk FSI File Upload entries. The contents of the Bulk FSI File cannot be amended.
- The authoriser may not be the same as the user that uploaded the Bulk FSI File.
- No filters are provided. On entry to the function, the list page is populated with all Bulk FSI Files with a status of Awaiting Authorisation.
- Selecting a row takes the user to the **Bulk FSI Authorisation Details** screen for that Bulk FSI File (the same details page is used in the **Bulk FSI Enquiry** function).
- Authorisation on Bulk FSI Upload is turned on by the RITS Help Desk at the member's request. Refer to the Authorisations User Guide.

5.2 Bulk FSI Authorisation Screen

Upon entry to the screen, all Bulk FSI Files in a status of Awaiting Authorisation are displayed. For Bulk FSI Files that were uploaded by the user, the **Authorise** check box will not be available.
